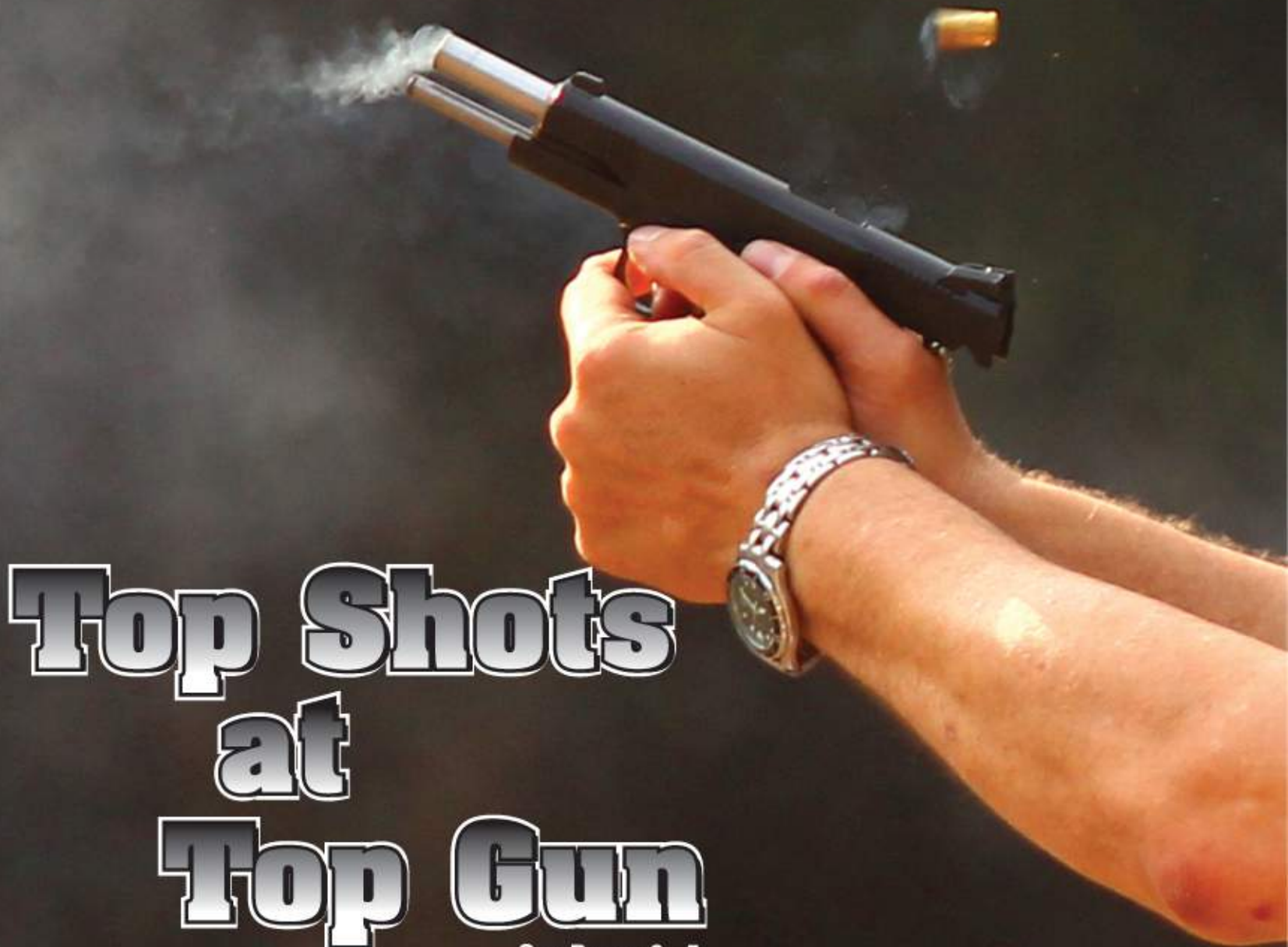

## Top Gun 2013

This was the fifth edition of LAPRAAC's Top Gun Team Challenge and it was by far and away our best. This was the second year in a row that the event sold out. Our facility can only handle thirty teams to successfully complete our goal of shooting the event, scoring the event and awarding the prizes all in the same day. This is a unique situation as many competitive shooters will tell you that they shoot an event and do not find out where they placed or what they have won for several days.

This year the shooter's shot four courses of fire, Bonus for a score, Combat for a score (ring scored), and two tactical ranges that were team events that were scored by the time it took the team to complete the run plus the penalty points for missed targets. This has been the standard for the past four years. This year due to the generosity of Extreme Airsoft there was a fifth stage that was not scored as part of the Top Gun, but provided an additional challenge for the teams. It is not just shooting that factors into a winning score it is selecting reliable team mates, Pacific who had high hopes at the beginning of the competition had one member of the team not able to compete the day of and they scrambled to get a fourth team mate to finish off their team. He arrived late, but allowed Pacific to finish the competition.

To keep the competition fair there are two categories, Open for those officers who are not competitive shooters and Elite, where Metro, Training Division Shooting instructors, Hits & Sits qualified officers are allowed to participate. Just one SITS officer on your team and you are now elite.

Each of the winning teams earned pistols as their prizes for winning their respective categories as did the second place team in the open category. The open category was won by Olympic Area who were awarded Berretta Nano 9mm pistols followed by Southeast who earned Ruger 380 pistols. The Elite division was won by Metro who received Sig Sauer P250 9mm pistols. Thanks to the generosity of our sponsors every team received eyes and ears on top of the T shirt and meal provided as part of the entry. Even better 29 of the thirty teams received an additional prize donated by our generous sponsors. The prizes were awarded after the steak dinner was served in the Daryl F. Gates Lounge.

Although we do not award for individual scoring as part of the competition, LAPRAAC does recognize that certain officers put together great rounds on the two static ranges (Bonus and Combat). In the Open category the top Bonus score was 392 recorded by Anthony Cabriaes, Allen Cheng, and Eduardo Ruvalcaba. Best Combat scores in the Open Category was again a 3 way tie at 297, Howard Choy, Young Jheon, and Greg Atteberry. The top Open shot was Anthony Cabriaes with a total of 687. In the Elite Category Eric Bixler was the man posting a 397 on Bonus and shooting a perfect 300 on Combat for a total of 697. Sergeant Lee McMillan from Metro also shot a perfect 300 on the combat range. Great job by everyone.

Earlier it was mentioned that there was an additional stage put on by Extreme Airsoft. Southeast Elite who came in second in the Top Gun competition won the airsoft segment and were awarded \$30.00 LAPRAAC gift cards.

LAPRAAC encourages those who have thought about competing to join in next year. Entries are limited to one per division up to a deadline date and then the competition becomes a first come first serve entry. This year multiple teams entered from North Hollywood, three, Southeast, three, Northeast, two, Mission, two, Rampart, two, and Metro, two. Eight spots were available for areas and divisions that were not represented this year.

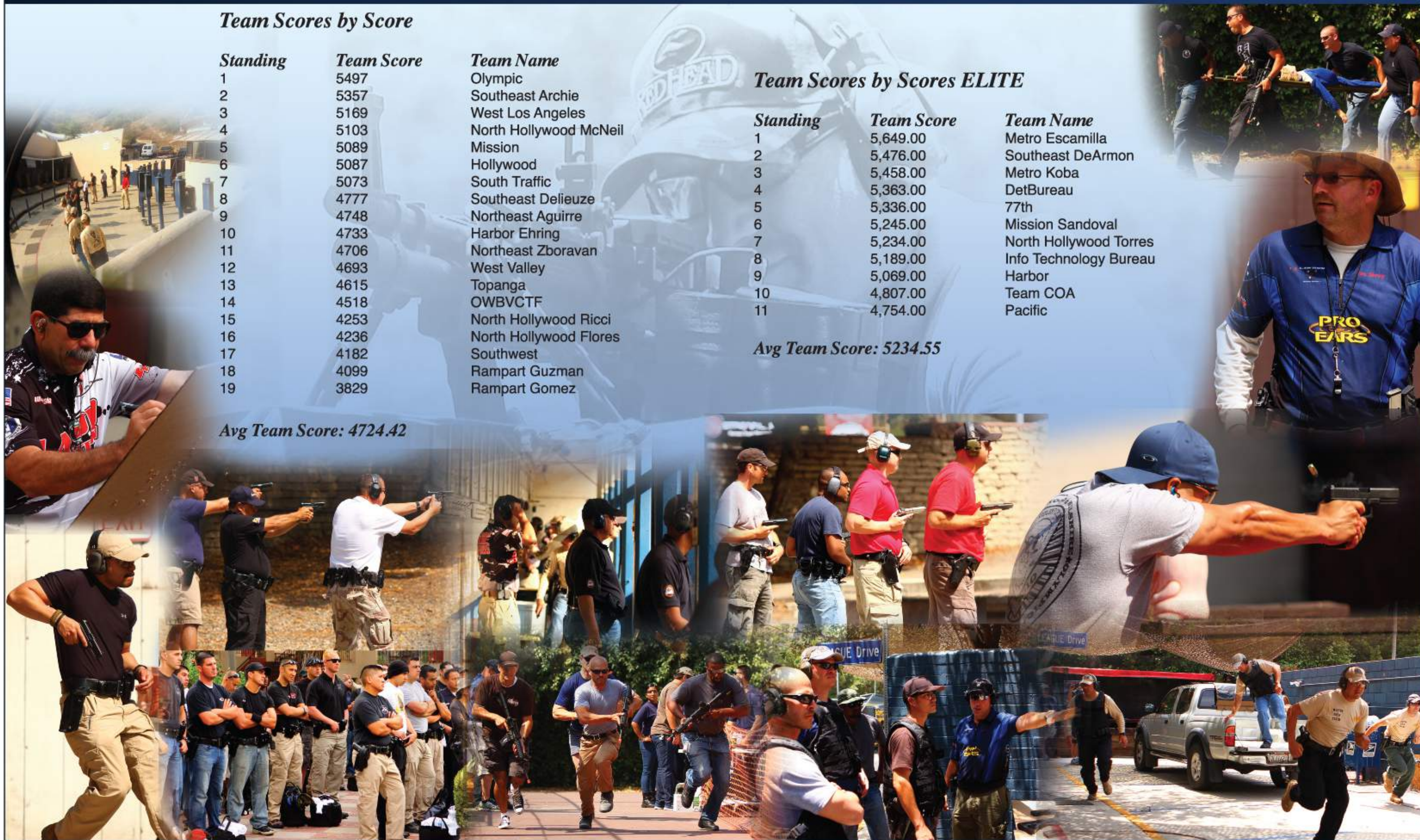

## 2013 US Police and Fire Games

*Cycling*

It was a great week for the LAPRAAC Cycling Team at the 2013 United States Police & Fire Championships coming home with a total of 20 medals. Several new riders displayed their cycling skills and joined in on camaraderie between the firefighters and law enforcement officers down in San Diego. The racing was challenging, leaving a few surprised riders on how competitive the events were. The road cycling format included a timed hill climb of approximately 2.7 miles, a forty-five minute criterium, a ten mile time trial, three individual sprint races along a 500 meter course, and a thirty mile road race with 3000 feet of climbing. An individual stage race category known as the Omnium was determined through a combined point system of each event. After the road cycling champions were crowned, the next day was settled on the track. A few intrigued riders who had never experienced the banking corners of the Velodrome learned how to make high speed turns around the oval. On the seventh day, the USPFC cycling gurus created mountain bike racing. The cross-country course consisted of twenty miles of steep climbs and 40+ mph descents at the Black Mountain Ranch. Overall it was a great time as our racers brought out their expensive bikes, family, friends, and camping rigs for a well-organized, worthwhile event for our public safety officers.

## Battle at the Academy: Great Fights for a great cause.

The Los Angeles Police Department Boxing Team sponsored by the Los Angeles Police Revolver and Athletic Club hosted the first annual "Battle at the Academy" this past July 6th here at the LAPD Academy. LAPD fighters competed against members of local law enforcement and firefighters in an amateur three round boxing match that was sanctioned by the United Combat Association. This charity event raised money for our Los Angeles Police Memorial Foundation, which provides financial assistance to the families of LAPD Officers killed in the line of duty.



The fight card consisted of 9 total bouts. In the second bout Welterweight Ray Encinas (LAPD) won by a unanimous decision by staying busy and delivering much more solid punches over his opponent. Next up featured junior Middleweight Eddie Montano (LAPD) who took on a more experienced and higher ranking fighter from the Santa Monica Fire Department. Both fighters were busy for the entire three rounds however Montano lost a close fight by a split decision.



In bout #4 LAPD's Brendy Ponce really lit up the home crowd with his very powerful punches. Fighting now as a light Heavyweight, Ponce took it to his opponent from the US Marshall's Office early and often. The fight went into the 3rd round with a clear advantage for Ponce but he did not wait for the judge's decision as he TKO'd his rival in the final round. Ponce is developing a reputation in the United Combat Association as a fearless fighter with very heavy hands. Next up was the super Middleweight class featuring LAPD's Aurelio Vasquez. He had to go against a Police Olympics former gold medal winner and higher ranked opponent from the Pasadena Police Department. Action filled fight Vasquez brought the fight to his opponent and gained a well deserving decision. A novice fighter who picked up the sport 18 months ago, Vasquez has quite a future and upped his record to an impressive 3-0.



The #1 light Heavyweight in the UCA is Mike Barragan from 77th Division. He showed why he is ranked #1 and used his superior skill and experience to gain the decision in the sixth bout of the day. Our Heavyweight (Bert Castaneda LAPD) was next up and was coming off a 1st round KO victory against the NYPD. It looked like he was going to do it again as he rocked his opponent and sent him to the canvas in the first round. However he recovered and the two exchanged punches for the entire bout with Castaneda earning the decision.



The final two bouts were some of the best. Chuck Wampler from Newton Division got the toughest draw of the card fighting the #1 ranked opponent from the Big Bear Fire Department. Although Wampler has had far fewer fights and experience he stayed in the bout with tenacity and an unbelievable motor. 3 solid rounds later Wampler gave the fans a great fight but lost the decision to the more experienced fighter. The final bout featured Welterweight Miguel Mejia who took on a San Bernardino Deputy Sheriff. Both fighters were evenly matched and brought a flurry of punches as neither fighter took a step backward during the entire fight. In the end the SBSB got the judges decision however with the action and drive of the fighters, this bout was awarded the fight of the night and nominated to be the fight of the year by the United Combat Association.

The LAPD Boxing Team has been at the forefront for over 20 years developing upcoming fighters and competing for the purpose of raising funds to needing charities. A fight card at a location rich in tradition on their home turf took several months to develop and the event was a success for the fighters and the hundreds of fight fans and families who came out on a hot Saturday to support the fighters and the cause.

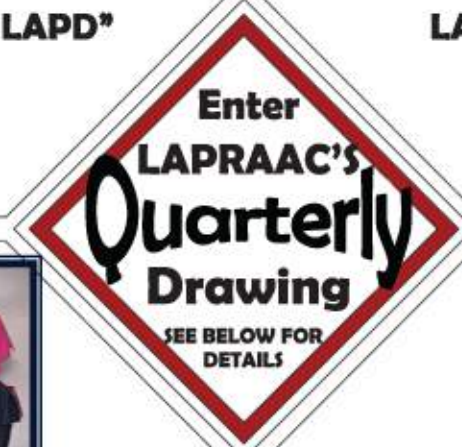
